[Mundelein, Illinois / Valparaiso, Indiana] – The City of Valparaiso, Indiana, Parks Department and GolfVisions Management, Inc. are pleased to announce the formation of a partnership wherein GolfVisions will work closely with the City's Parks and Recreation staff to enhance the golf operations at Forest Park Golf Course and Creekside Golf Course & Training Center.

The City owns and operates two facilities, Forest Park Golf Course and Creekside Golf Course & Learning Center. The more centrally located Forest Park is an 18-hole layout that marries a traditional parkland front 9 to a rugged back 9 with challenging elevation changes. Creekside offers a links-style full-length 9, a 3-hole short course, and a teaching facility comprising a 48-station driving range with a heated/covered tee box, putting green, and chipping area.
