**Waukegan Park District Selects GolfVisions Management, Inc.  
to Operate Bonnie Brook, Greenshire**

Waukegan, Illinois – After a national search and a comprehensive, multifaceted evaluation process that spanned more than eight months, the Waukegan Park District has selected Chicagoland-based GolfVisions Management, Inc. to operate the District's golf facilities, 18-hole Bonnie Brook Golf Course and 9-hole Greenshire Golf Course.

Bonnie Brook, an acclaimed championship 18, "rivals North Shore country clubs in its beauty and conditioning," said GolfVisions President Tim Miles, Sr. "This is a jewel of the community, and we will work hard to ensure it remains the treasured home course of its many season members while raising its profile to draw daily-fee golfers from throughout Chicagoland to experience this fantastic course."

GolfVisions anticipates that Greenshire, a pretty, player-friendly 9, will continue to draw golfers who have favored its low-key atmosphere and shorter length. "We'd also like to position Greenshire as the gateway course for drawing new golfers--juniors, ladies, minorities and other underrepresented populations--into the game," noted Miles.

The Waukegan Park District issued a nationally distributed RFP (Request for Proposal) last spring and then engaged in an exceptionally thorough evaluation process to "vet" three finalists to manage its golf facilities. GolfVisions was approved by unanimous vote on Tuesday, November 13 and officially assumed operations on Saturday, December 1.

"With the selection of GolfVisions, the Waukegan Park District hopes for a seamless transition into this new era of golf at our courses," commented Board of Commissioners President Bill Sarocka, "Our goal is to sustain future golf services at the highest level as our customers have enjoyed over the years."
